

THE BIG LOTS BACK TO CAMPUS SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. By participating in the Big Lots Back to Campus Sweepstakes, each Entrant (the "Entrant") unconditionally accepts and agrees to comply with, and abide by these Official Rules and the decisions of Big Lots Stores, Inc. ("Big Lots" or "Sponsor"), which shall be final and binding in all respects.

ELIGIBILITY: The Big Lots Back to Campus Sweepstakes (the "Sweepstakes") is open to legal residents of United States (excluding Rhode Island) who are 18 years of age or older at the time of entry. PRIZES/APPROXIMATE RETAIL VALUE ("ARV")/ODDS: There are four (4) prizes available to be won, one (1) prize for each Entry Period as depicted in the Entry Period & Prize Drawing Schedule above.
