

JOY TO YOU AND ME SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. By participating in the Sweepstakes, each Entrant (“Entrant”) unconditionally accepts and agrees to comply with, and abide by these Official Rules; the decisions of Big Lots Stores, Inc. (“Sponsor”), which shall be final and binding in all respects.

PRIZES/APPROXIMATE RETAIL VALUE (“ARV”)/ODDS:

Prize: Up to three (3) prize winners will be randomly chosen. Each prize winner will receive the 2 Big Lots gift cards valued at \$250 each—one for the prize winner and one for a friend. **The ARV of each Prize is: \$500.00.**
